

RULES FOR PAINTBALL AVENTURA



1. PLEASE WEAR ALWAYS THE MASK DURING THE GAME. NEVER REMOVE IT UNTIL YOU ARE OUT OF THE FIELD EVEN IF YOU ARE ELIMINATED
2. RESPECT FIELD LIMITS. IF NOT YOU WILL BE ELIMINATED
3. In case you run out of balls and need to refill please go to neutral area. You have 5 min maximum to return to game
4. Please do not shoot anyone or anywhere while you are on the neutral area
5. MAKERS IN THE NEUTRAL AREA MUST ALWAYS BE DOWNLOADED, WITH THE ISAFETY CAATCH PLACED AND POINTING TO THE GROUND.
6. YOU ARE NOT ALLOWED TO USE EQUIPMENT NOT AUTHORIZED FOR PAINTBALL AVENTURA
7. If you are closer than 5 METERS TO ANOTHER PLAYER YOU ARE NOT ALLOWED TO SHOOT, simply inform that the player is eliminated. IF YOU DO NOT RESPECT THE SAFETY DISTANCE PINTBALL AVENTURA IS NOT RESPONSIBLE FOR THE DAMAGES THAT YOU COULD CAUSE.
8. Never use used balls or unauthorized objects as paintballs. Markers can be damaged or blocked and you will be responsible for it.
9. NO VIOLENCE OR AGRESSION IS ALLOWED. PLEASE RESPECT PLAYERS AND VISITORS
10. NOT INTIMIDATE VISITORS OR STAFF WITH MARKERS
11. IF YOU ARE UNDER 18 YOU NEED PARENTS PERMISSION
12. THE IMPROPER USE OR MALTREATMENT OF THE EQUIPMENT, WILL CONSTITUTE THE REPLACEMENT OF 100% OF IT
13. IT IS FORBIDEN TO SMOKE ANY PLACE EXCEPT THE ONES AUTHORIZED FOR IT BY Nipies S.L.
14. NIPIES SL IS NOT RESPONSIBLE FOR THE ACCIDENTS CAUSED FOR THE BROKEN RULES, NEITHER FOR ANY INCONVIENCE CAUSED FOR THE CLIMA OR THE COMMON USE OF THE FACILITIES
